

Bryan College of Health Sciences
Coronavirus Response and Relief Supplemental Appropriations Act
September 30, 2021 Quarterly Report for Emergency Grants to Students
Updated April 8, 2022

(1) An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.

Bryan College of Health Sciences (BCHS) signed and submitted the Recipient's Funding Certification and Agreement for the Coronavirus Aid, Relief and Economic Security (CARES) Act and by drawing down funds from Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA), agrees to the conditions of each of these programs and assures that BCHS will use the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.

(2) The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

BCHS has received \$242,209 in student aid funds under CRRSA.

(3) The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as of the date of submission (i.e., as of the initial report and every calendar quarter thereafter).

As of September 30, 2021 BCHS has distributed \$242,209 in CRRSAA student aid funds to students. Additionally, BCHS has distributed \$523,811 in CRRSA institutional funds to students. This totals \$766,020 in CRRSAA funds that BCHS has distributed to students. BCHS has also distributed remaining funds from the Coronavirus Aid, Relief and Economic Security (CARES) Act of and all funds from the Funds for the Improvement of Postsecondary Education (FIPSE) to students, both totaling \$114,667.

(4) The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

The estimated student's eligible to receive Emergency Financial Aid Grants under CRRSA was 922.

(5) The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

The total number of students who have received an Emergency Financial Aid Grant to students is 632 students under CRRSAA.

(6) The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.

To be eligible for CRRSAA funds, students are required to be a US citizen or eligible non-citizen and enrolled in a degree, non-degree or certificate program in the fall 2020 and/or spring 2021 academic terms. Students were given the option to apply their grant to their student account for any unpaid balances or receive the grant directly.

- Below is the methodology used to calculate Emergency Financial Aid Grants to students under CRRSAA for the fall 2020 term. Student's FAFSA data was used to prioritize students of need based on their Expected Family Contribution (EFC):
 - Students with an EFC of 0-10,000 and enrolled in a degree program in the fall 2020 term is eligible to receive an \$850 grant
 - Students with an EFC of 10,001-15,000 and enrolled in a degree program in the fall 2020 term is eligible to receive an \$620 grant
 - Students with an EFC of more than 15,000 and enrolled in a degree program in the fall 2020 term is eligible to receive an \$390 grant
 - Students enrolled in a non-degree program in the fall 2020 term is eligible to receive an \$160 grant

- Below is the methodology used to calculate Emergency Financial Aid Grants to students under CRRSAA for the spring 2021 term. Student's FAFSA data was used to prioritize students of need based on their Expected Family Contribution (EFC):
 - Students with an EFC of 0-10,000 and enrolled in a degree program in the spring 2021 term is eligible to receive an \$810 grant
 - Students with an EFC of 10,001-15,000 and enrolled in a degree program in the spring 2021 term is eligible to receive an \$555 grant
 - Students with an EFC of more than 15,000 and enrolled in a degree program in the spring 2021 term is eligible to receive an \$300 grant
 - Students enrolled in a non-degree program in the spring 2021 term is eligible to receive an \$160 grant

(7) Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Students received communication from BCHS's Financial Aid Department via email notifying them of the opportunity to receive Emergency Student Grants. Financial Aid's ongoing communications guided eligible students to a process where they could accept these grant funds. These communications included guidance on how to apply for Additional Emergency Grant Assistance.
